Residents commented on:

1. Bench location in Bawdsey Park – location will they be near the equipment or near the properties?

A. Should be nearer to the equipment so as not to disturb residents.

2. Bawdsey Path that joins Hodgeson's Way is an uneven area, can this be repaired?

A. Unfortunately the Parish Council has limited powers but we will continue to request improvements from Basildon.

3. Barrier lock and post at the gate at Bruce Grove when will this be repaired and replaced?

A. Order has been requested to be reinstated confirmed Cllr. Buckley and after the report received for excavation due to electricity etc., it should be a couple of weeks.

4. Situation regarding the travellers?

A. The landowner is required to take the action if they want removal from their premises.

Annual Report May 2016 – March 2017

Dear Resident,

This is the Tenth Annual Report published by the Parish Council which is almost in its third year of its third term of office and has been a very busy year and I must observe how the council has been very involved.

CHAIRMAN'S REPORT 2016/17

1. Residents Involvement:

It was a pleasure to see so many residents turn up to attend council meetings, getting involved in local issues that they are really concerned with. At one meeting alone, we must have had at least 80 people attend and your Parish Council was happy to see them.

2. ECC Community Payback:

This has progressed during the year with Parish Councillors heavily involved with the liaising of this service and the results are very visible with parks returned to full width. Shrubs and bushes cut back and regular in depth litter picking occurring on a very regular basis. Painting of play equipment and one of the keys to this successful project is the co-operation of the Baptist Church who allow us to use the hall as a base for our councillors and the Pay Back Team. Although currently not underway, this operation will recommence in the Spring and any ideas from our residents to assign them will be considered.

3. Liaison with Other Authorities:

We have continued to work with Basildon Borough and Essex County councillors to raise concerns and liaise with them to pursue answers on various issues and highlight Highways problems – i.e. potholes, drainage in the area and in some of these, we have had various levels of success.

4. Specific Local Interest:

Local Plan 2016 Consultation (new houses) – February 2016.

Fanton Walk application for houses – June 2016, objection due to over development of site.

5. Grants Awarded Projects – Sensory Area:

With all the financial restraints, it was very pleasing to be offered a grant from ECC CIF Fund of just over £13,000.00 towards the under utilised space to the rear of the play equipment in Shotgate Park and this is scheduled to be an open sensory area with another pathway leading to sleepers of plants, additional benches, more wild flowers and the rear pathway to the rear will be resurfaced to enable easier access.

Bawdsey Path:

There will be a newly installed pathway between the fitness equipment to minimise on the poor weather between these items and a bench for visitors.

6. Foundation Award:

The Parish Council was awarded the Foundation Award last year for its efforts to obtain a professional and pro-active Council.

7. Newsletter:

A big thank you to residents that have kindly distributed the newsletter during the past year, without your time the Parish Council would have had great difficulty delivering within the Parish. The format and distribution is being reviewed as it appears the present system is unlikely to continue.
